An order to show cause why judgment should not be entered against Furukawa was issued on June 23, 2005. Papers 27 and 28 (errata). Furukawa responded. Paper 29. The response was held to be insufficient. Paper 30. Furukawa was provided an opportunity to supplement its response to the order to show cause on or before August 22, 2005. Paper 30, p. 2. No supplemental response has been filed. Counsel for Furukawa confirmed that no response had been filed. Accordingly, it is appropriate to enter judgment against Furukawa.

ORDERED that judgment on priority as to the subject matter of Count 1 (Paper 1, p.3), is awarded against the junior party, FURUKAWA ELECTRIC NORTH AMERICA;

FURTHER ORDERED that junior party, FURUKAWA ELECTRIC NORTH AMERICA, is not entitled to a patent containing claims 1-13 (corresponding to Count 1) of U.S. Patent 5,694,503;

FURTHER ORDERED that a copy of this judgment be made of record in the file of U.S. Patent 5,694,503 and 09/203,166;

FURTHER ORDERED that if there is any settlement agreement which has not been filed, attention is directed to 35 U.S.C. § 135(c) and 37 CFR § 41.205.
