Judgment is entered against junior party Luciw.

Upon consideration of the record, it is

ORDERED that judgment on priority is entered against junior party Paul A. Luciw and Dino Dina;

FURTHER ORDERED that junior party Paul A. Luciw and Dino Dina is not entitled to a patent containing claims 1-45 of its patent 6,531,276, which claims correspond to Count 1, the sole count of the interference. (Paper 1 at 5);

FURTHER ORDERED that, if there is a settlement agreement the parties are directed to 35 U.S.C. § 135(c) and Bd.R. 205; and

FURTHER ORDERED that a copy of this judgment and the Decision on priority (Paper 143) shall be entered into the administrative records of Luciw's 6,531,276 patent and Chang's 06/693,866 application.
