6 **A. Introduction**

7 Interference 105,640 was declared on 24 June 2008. No papers have been  
8 filed on behalf of the junior party Parke as required by Board Rules and the

1 Standing Order.<sup>1</sup> Moreover, Parke has not timely filed a response to the Order to  
2 Show Cause (Paper 3).

3 On 22 July 2008, Board personnel, Sonja Desperett, telephoned Mr. Scott  
4 Lowe, counsel of record for Parke to inquire why Parke had not filed their initial  
5 papers and a response to the Order to Show Cause. Mr. Lowe informed Ms.  
6 Desperett that Parke will not file any papers or respond in any way to the Order to  
7 Show Cause. Mr. Lowe's representation that Parke will not respond to the Order  
8 to Show Cause is an abandonment of the contest. An abandonment of the contest  
9 is construed as a request for adverse judgment. Bd. R. 127(b)(4).

10 Accordingly, it is

11 **ORDERED** that judgment be entered against Parke for count 1 (Paper  
12 1 at 4);

13 **FURTHER ORDERED** that claims 67-73 of Parke's involved  
14 application are FINALLY REFUSED, 35 U.S.C. 135(a); and

15 **FURTHER ORDERED** that a copy of this judgment be entered in  
16 the administrative records of the involved Parke application and Wiekhorst patent.
