INTRODUCTION

A motions panel decision dated 7 January 2000 placed Sproat under an order to show cause within twenty-eight days why judgment should not be entered against Sproat (Paper No. 59 at 23). No response is of record.

ORDER

Upon consideration of the record of this interference, it is-

ORDERED that judgment on priority as to the sole count is awarded against junior party Sproat;

FURTHER ORDERED that junior party Sproat is not entitled to a patent containing claims 1-23 of Sproat's 5,658,731 patent, which correspond to the count;

FURTHER ORDERED that, based on the record before us, senior party Cook is entitled to a patent containing claims 9, 10, and 15-27 of Cook's 07/967,267 application, which correspond to the count; and

FURTHER ORDERED that a copy of this decision be given a paper number and be entered in the administrative record of Sproat's 5,658,731 patent and Cook's 07/967,267 application.
