3 2. Defendant is liable to Plaintiff for unfair competition under federal law, 15 U.S.C.  
4 § 1125, and under the laws of the State of California;

5 3. Judgment is hereby entered in favor of Plaintiff J Star Motors, Inc. and against  
6 Defendant Jeffrey Steigner, as follows:

7 a. Statutory Damages: \$90,000.00;  
8 b. Attorneys' Fees: \$10,000.00  
9 c. Discovery Sanctions: \$1,845.00  
10 c. Costs: \$350.00;  
11 **Total Judgment: \$102,195.00.**

12 4. This judgment shall accrue interest, compounded annually, pursuant to 28 U.S.C.  
13 § 1961.

14 5. Defendant shall be permanently enjoined from further infringing on Plaintiffs'  
15 trademark. This Court contemporaneously issues a separate permanent injunction.
