

13 **STIPULATION OF DISMISSAL**

14 IT IS HEREBY STIPULATED, by and between plaintiffs Fraser Ross and
15 A-List Inc. ("Plaintiffs") and defendant Ciro Paone SpA ("Ciro Paone"), that:

17 1. Plaintiffs filed the above-captioned lawsuit against Ciro Paone and
18 Chemilt AG on July 28, 2006.

19 2. Ciro Paone filed its answer, affirmative defenses and counterclaims on
20 December 18, 2006.

21 3. Plaintiffs and Ciro Paone have agreed to settle their claims and
22 counterclaims against each other in the above-captioned lawsuit, pursuant to a
23 settlement agreement dated November 5, 2007 ("Settlement Agreement").

24 4. Plaintiffs hereby dismiss its claims against Ciro Paone and Chemilt
25 AG pursuant to Federal Rule of Civil Procedure 41(a) with prejudice.


26 5. Ciro Paone hereby dismisses its claims against Plaintiffs pursuant to
27 Federal Rule of Civil Procedure 41(a) with prejudice.

1 6. Each party will bear its own legal expenses, including without
2 limitation, attorneys' fees and costs.

3 7. The parties agree and acknowledge that the Settlement Agreement
4 includes certain ongoing obligations, including that Plaintiffs will take all necessary
5 steps to amend any trademark registration or application for KITSON worldwide
6 pursuant to paragraph 5 of the Settlement Agreement, and that nothing in this
7 dismissal shall limit or obviate that obligation, or any of the other rights and
8 obligations of the parties in the Settlement Agreement.




